### University of Colorado Law Clinics

Colorado Law's Clinical Education Program provides free legal services in certain circumstances to Coloradans. Each clinic has different guidelines for selecting cases and not all clinics accept calls from individuals who are interested in representation.

See the specific clinic guidelines below to learn whether our clinics might be able to help you.

**American Indian Law Clinic**, 303-492-8126. Assists low-income persons only with cases involving issues of federal or tribal law, such as: situations involving the federal Indian Child Welfare Act, discrimination in housing, education or employment, tribal membership issues, protection of Native sacred lands and challenges to the free exercise of religion. This Clinic also takes on a limited number of tribal code writing projects each year.

**Civil Practice Clinic**. Primarily handles cases in family law and Social Security disability, and only accepts cases that are referred by Colorado Legal Services. The clinic only takes new cases at the beginning of the school year in early September. If you are low-income, live in Boulder County, and need help on a family law matter, call Boulder County Legal Services, 303-449-7575. If you live in Boulder or the greater Denver area, and need help on a Social Security disability case, call Colorado Legal Services, 303-837-1313 to be screened for services. The Clinic also takes a limited number of refugee asylum cases each year. Call 303-492-8126.

**Criminal Defense Clinic**, 303- 492-8126. Limits its representation to misdemeanor and traffic cases in Boulder County, and provides services only to indigent persons. The clinic accepts new clients primarily at the beginning of each semester--early September to October, and mid-January to February.

**Entrepreneurial Law Clinic**. Provides transactional legal services to local entrepreneurs who are trying to start a business in Colorado. Student attorneys provide services only during the school year. [Complete and submit the application form here](#).

**Technology Law & Policy Clinic**. Works in the public interest to analyze technology law policy issues. The clinic does not represent individuals.

# Colorado Legal Services

## Income Guidelines

The following maximum income levels, which are based on 125% of the latest revisions of the Federal Poverty Guidelines determined by the Department of Health and Human Services and approved by the Legal Services Corporation, should be used to determine client eligibility effective May 1, 2016. The guidelines are based on gross income.

| Size of Family | 2015           | 2015          |

For family units with more than eight (8) members, add \$5,200/year or \$433/month for each additional member in the family. These guidelines are based on gross income.

### Type of help

There are several ways in which a legal organization can provide help:

- Full representation - representation by a lawyer or a legal advocate in court or at a hearing.
- Brief advice - quick advice in person or over the telephone.
- Legal clinics - clinics offered to help individuals seeking legal information about particular issues, for example uncontested divorce.
- Self-help materials - online resources, or print resources including flyers or brochures available to individuals to help them gain better understanding of their rights and the legal process.

### Income exceptions

An organization may also list instances in which it can assist a person whose income is higher than the income guidelines. For example, an organization may make exceptions for seniors, people experiencing domestic violence, or people who are facing an eviction. Some organizations determine income eligibility by taking expenses such as child care, medical bills, and debts into account.

can ask your school or college who its designated individual is and then contact them to file a complaint of sex or disability discrimination, including harassment on the basis of sex or disability.

Workers used this money to put food on their tables, stabilize their housing situations, and pay off their debts.
